Kentucky Nonprofits Celebrate \$75 Million Investment at State Capitol

State Association of Nonprofits Releases Data on the Impact of Kentucky's \$75 million American Rescue Plan Act Appropriation for Relief, Presents Advocacy Awards

(FRANKFORT, Ky.—) Kentucky Nonprofit Network, the state association of nonprofits, returned to the state Capitol yesterday after a three-year hiatus due to the pandemic to celebrate Nonprofit Day at the Capitol and more specifically, celebrate the impact of a \$75 million investment of State Fiscal Recovery Funds from the American Rescue Plan Act of 2021 in relief grants for eligible nonprofit organizations. Lt. Governor Jacqueline Coleman, Senate President Pro Tempore David Givens, and Minority Caucus Chair Representative Cherylynn Steveson were on hand for a rally in the Rotunda announcing the impact of the funding.

The \$75 million appropriation was included in the Kentucky General Assembly's 2022-2023 budget, and signed into law by Governor Andy Beshear effective July 1, 2023. The legislation permitted relief grants of up to \$100,000 per nonprofit meeting specific eligibility criteria, which included the organization suffering revenue losses or increased expenses due to the pandemic. Danielle Clore, Kentucky Nonprofit Network's CEO, reported the impact of the funding:

- 1146 grants were awarded to eligible nonprofits.
- Recipients were located in 103 of Kentucky's 120 counties, though many recipients provide services statewide and Clore noted that as a result, every Kentucky city and county benefited.
- 10% of the grants were awarded to eligible arts nonprofits.
- The average grant amount received was just under \$63,000.
- Nearly 45% of grant recipients had suffered such significant revenue losses or incurred such significant increases in costs, that they received the full allowable grant amount of \$100,000.

Clore reported that nonprofits have used the funding for everything from hiring staff to alleviating wait lists for services, to making long overdue capital improvements, to paying off lines of credit that organizations had accessed to meet payroll expenses. "These dollars went to work immediately in communities across Kentucky – helping to keep people employed, pumping money back into Kentucky's economy, and most importantly, keeping the programs and services available to Kentuckians and communities who need them," Clore said.

"The \$75 million funded by the American Rescue Plan Act, agreed upon in a bipartisan way between the Governor and the legislature, has been a life saver to many nonprofits," said Lt. Governor Jacqueline Coleman. "The problems nonprofits are working to solve aren't Democrat problems and they aren't Republican problems. They are Kentucky problems," added Coleman.

As employers of one in ten Kentuckians, nonprofits are essential to meeting the needs in Kentucky communities, as was never more evident than during the pandemic.

"Thank you for the work you do in our communities, meeting the needs of so many of our citizens and in so many different ways," said Senator David Givens (R-Greensburg), a member of the Nonprofit Legislative Caucus. Representative Cherylynn Stevenson (D-Lexington), a Nonprofit Legislative Caucus Co-Chair concurred, "Every day is nonprofit day in the Commonwealth because each of you, and tens of thousands of others like you, make a profound and lasting impact throughout the year."

As part of the rally, Kentucky Nonprofit Network (KNN) presented awards to Lt. Governor Coleman; House and Senate leadership; and representatives of the Public Protection Cabinet, who administered the grant program.

The Day's activities also included other awards presented to KNN members and the legislators and state officials who championed legislative efforts. KNN presented 13 member organizations with Nonprofit Voice Awards, recognizing their demonstrated excellence in public policy during the General Assembly's 2021 and 2022 Regular Sessions, and presented 36 Nonprofit Advocacy Partner Awards to legislators and officials for their support of the members' efforts.
