

# 2020 Outstanding Board Leadership Award

The Outstanding Board Leadership Award recognizes an individual providing outstanding leadership through service on a board of directors of a 501(c)(3) nonprofit organization in Kentucky. The award highlights the work of an outstanding board leader who is a strategic thinker, works cooperatively with other board members and the organization's executive director to further the mission of the organization, and is actively committed to best practices and succession planning.

### **Award Recognition:**

- Virtual award presentation
- Recognition in the KNN e-newsletter, social media, and on the KNN website
- One year KNN membership for the winner's current (or other designated) organization
- \$1000 provided to the recipient's current (or other designated) organization

### **Award Criteria:**

- Nominee must be serving or have served on the Board(s) of Directors of a nonprofit organization in Kentucky to be eligible. Local chapters of national organizations may nominate board members.
- The organization for which the nominee serves must be a registered 501(c)(3).

### **Instructions/Nomination Requirements:**

- 1. Submit the Nomination Application
- 2. Answer the three (3) specific questions in the Application (on this page or submit in a separate document)
- 3. Up to three letters of support may be submitted addressing why the nominee deserves consideration for the award. Each letter should be no longer than two double-spaced pages, with a 6 page maximum. You may also choose to substitute a letter(s) with short vidios (up to three minutes in length each, amateur submission is acceptable, professional videos are not required simply submit a video recording in mp4 format while using a file sharing service such as Dropbox.
