

2020 Distinguished Nonprofit Leadership Award

The Distinguished Nonprofit Leadership Award recognizes outstanding leadership among Kentucky nonprofit chief executives. The award recognizes achievement in the areas of strategic leadership, community building, ethical integrity, innovation and commitment to strengthening the nonprofit sector.

Award Recognition:

- Virtual award presentation and
- Recognition in the KNN's e-newsletter, on the KNN website and via social media
- One year KNN membership for the recipient's current (or other designated) organization
- \$1000 provided to the recipient's current (or other designated) organization

Award Criteria:

- The nominated individual must have at least fifteen (15) cumulative years of nonprofit professional experience as of September 1, 2020.
 - > Individuals must have served as a chief executive for a minimum of five (5) years
 - The additional ten (10) years may be as a chief executive or in a senior leadership position of one or more organizations
- The following criteria will be considered in selection of the award recipient:
 - Innovation a leader who is perpetually searching for new ways, solutions, and unconventional forms of work; adapting to the changing environment; and suggesting new ways of solving problems.
 - Community Building a leader who reaches out into the community to build relationships with other organizations to encourage partnerships and collaboration to prevent duplication of services and provide the best level of service for the community.
 - Ethical Integrity –a person who can be looked to as an example of personal values that promote ethics and integrity in the nonprofit sector.
 - Strategic Leadership a leader committed to establishing a professionally-managed organization with the appropriate systems in place to assure its endurance and future success, including a commitment to diversity, equity and inclusion efforts.
 - Commitment to Strengthening the Sector a leader committed to mentoring the next generation of nonprofit professionals and is actively engaged in activities that elevate and strengthen the nonprofit sector

Instructions/Nomination Requirements – due by 5pm EDT, November 6, 2020:

- Submit a nomination narrative, up to six (6) pages, via Microsoft Word or Adobe PDF to support this individual's nomination. This may include resume outlining experience (if resume is not available –simply attempt to outline career history in the nomination), up to three (3) letters and/or short videos of support, etc. If using video, please keep any videos under three minutes in length, amateur submission is acceptable, professional videos are not required simply submit a video recording in mp4 format using a file sharing service such as Dropbox. Use KNN's Dropbox link, here: https://www.dropbox.com/request/jGG7RvwuTcmYtfZau31U), etc. (Recommended, but not required.) The narrative should include:
 - Brief outline of the nominee's career history. Please include the names of organizations served, dates employed, significant career accomplishments/highlights at each and any awards or recognition received.
 - Please address why you think the nominated individual is deserving of the Distinguished Nonprofit Leadership Award, including any specific examples of the criteria above (Innovation, Community Building, Ethical Integrity, Strategic Leadership and Commitment to Strengthening the Sector).
 - Tell us how has the nominee's leadership inspired the stakeholders (board, staff, clients, and/or community) of the organizations he or she has served?
 - > Please share at least one example that best expresses the nominee's leadership legacy.
