81% Program Revenue (\$415.5 million)
(including fee for service income and government grants and contracts)



16% Contributed Revenue (\$82.3 million)
(private donations from individuals, foundations, corporations, and bequests)



3% Other Revenue (\$16.1 million)
(investment and interest income, etc.)

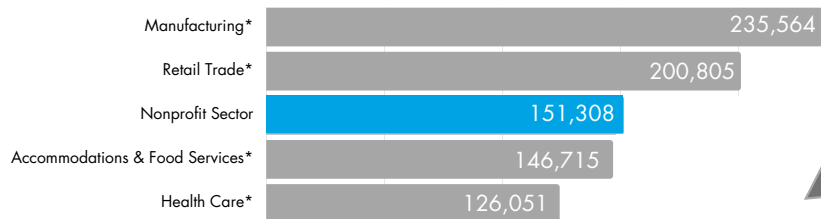

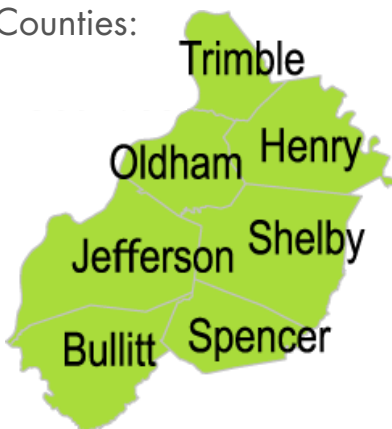
